I envision myself caring for entire families and, by extension, the broader community. I aspire to own a private practice, where I can see patients in the clinic for regular visits and procedures, while also maintaining hospital privileges to assist with labor and delivery.

To achieve this, my first step is completing residency. I hope to train in an urban setting with strong ties to underserved rural areas, as this would provide the perfect bridge from my suburban upbringing to practicing in a smaller town. After residency, I plan to establish my career in a rural area, preferably in West Texas or Colorado, where the need for dedicated physicians is significant.

Beyond my medical aspirations, I also value balance in life. I aim to be an engaged member of my community, a devoted husband, and a loving father. Additionally, I have a passion for writing and education. One of my long-term goals is to publish work on medical etymology, bringing attention to the origins of medical terminology in a way that is both engaging and educational.
